## City of Springfield Sewer Garage Stormwater Capture and Reuse

Lee Bloome, Water and Wastewater Infrastructure Engineer, Hanson Professional Services Inc.

The City of Springfield enlisted Hanson for its sewer garage stormwater capture and reuse project, which entailed designing and constructing a system to filter stormwater to reduce runoff and improve stormwater quality. Hanson also designed a water reuse system as part of the stormwater collection framework, which included using a hydrodynamic separator to clean out the larger debris and oils, running the water through a filter and storing it in tanks for the city's use. The project's preliminary design package included the Illinois Green Infrastructure Grant Program's best management practices application. The project received a Top Storm Water & Erosion Control Projects award from Storm Water Solutions magazine.

An Opportunity Zone is an economically-distressed community where new investments, under certain conditions, may be eligible for preferential tax treatment. Localities qualify as Opportunity Zones if they have been nominated for that designation by the state and that nomination has been certified by the Secretary of the U.S. Treasury via his delegation of authority to the Internal Revenue Service. Opportunity Zones were added to the tax code by the Tax Cuts and Jobs Act on December 22, 2017. Opportunity Zones have now been designated in all 50 states
